Wiring Overview



Always connect to power using a fuse or breaker 15 Amp




Connect Yellow wire to the yellow accessory wake up wire of the HDS. SonicHub will turn on when the HDS is turned on.



Connect SAT IN (AUX 2)


The **SAT IN** input can be from a LWX-1 weather module to listen to Sirius satellite radio. Or it can be connected to some other line level audio source (AUX2).

LWX-1 Weather Module




Connect to Line Level Amplifier

Connect to a Subwoofer


The **Sub Out** connection is a Mono Line Level output from both RCA connectors.






Connect MIC
